**Date:** 17.01.2023

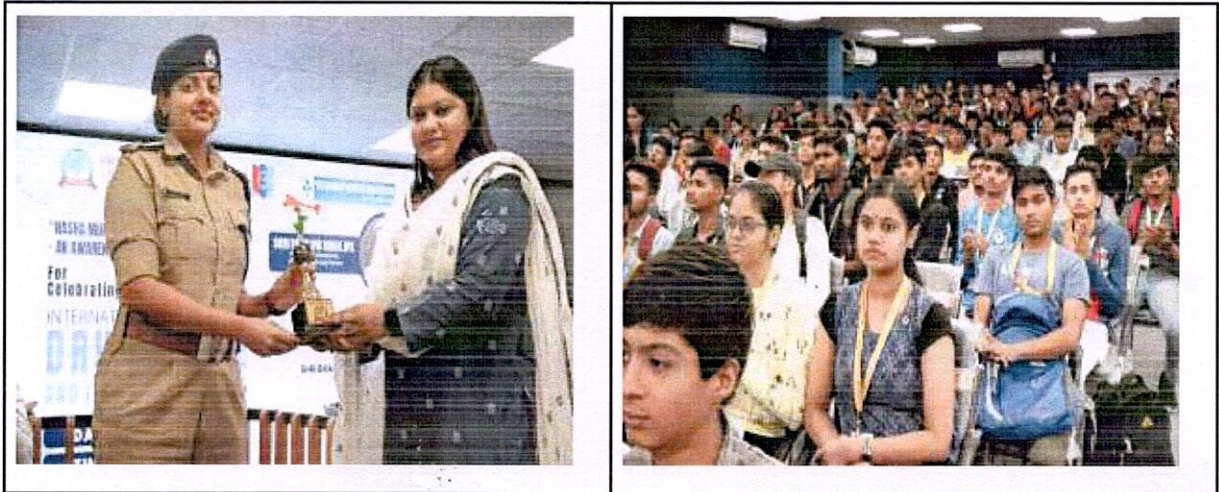
**Guest Speaker:** Dr. Lavina Sinha, IPS, Deputy Commissioner of Police, Ahmedabad City Police

On 17th January 2023, Silver Oak University organized a session titled "Respect and Responsibility: Addressing Ragging and Drug Awareness" to raise awareness about the dangers of ragging and drug abuse. The session was led by Dr. Lavina Sinha, IPS, Deputy Commissioner of Police, who highlighted the severe consequences of both issues on students' well-being and the legal actions associated with them.

Dr. Sinha discussed the forms of ragging, its psychological impact, and the need for a supportive campus culture. She also addressed the rising concern of drug abuse among youth, offering advice on prevention and available support systems. An interactive Q&A session followed, where students and faculty raised concerns and received practical guidance.

The session concluded with a call to action for the entire campus community to foster a safe, respectful, and drug-free environment.

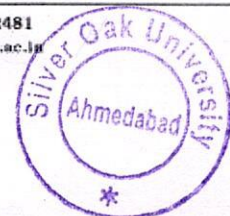

**Expert Name :** Swamishri Krishnaviharidasji, ISKCON Temple

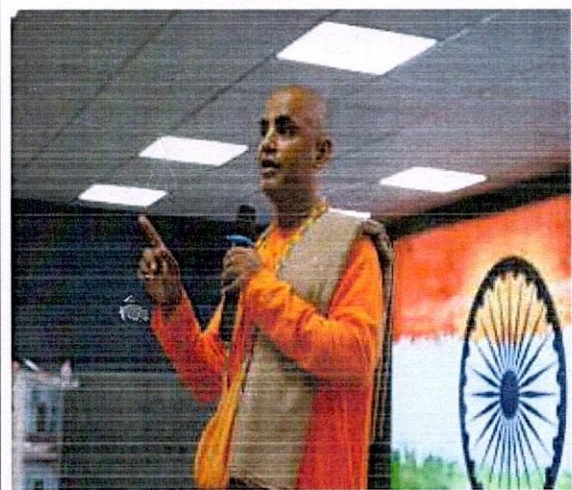

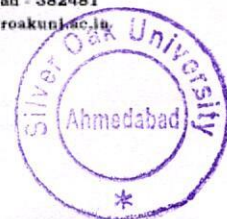
